Understanding your Prophecy

1. Play back the prophecy and then write it out. Read it several times and ask the Lord about anything that is unclear. Discuss it with your pastor/oversight and ask for his/her input.
2. Receive the prophetic word with faith and acceptance.
3. Look at any previous prophecies you have received, and look for confirmation.
4. Realise that the first interpretation is not necessarily the right one. There can be a number of interpretations of the same word.
5. Witness to your prophecy with your spirit – not your mind, emotions, personal opinions or goals. Realise that God can use a prophecy to speak new revelations as well as confirm any words from the past.
6. Speak the words of your prophecy aloud (1 Timothy 1:18).
7. Don't make any significant changes unless you are definitely directed to do so – keep doing what you are doing until God has directed you to change.
8. You need to be patient to see the fulfilment of God's will.
9. Receive the word in a spirit of humility, meekness and submission – don't negate God's word by receiving it in the wrong spirit.

General guidelines

1. A prophecy over can never replace seeking God yourself. It can never be a substitute for prayer, fasting and studying the Word.
2. A prophecy over is not the only way that God can reveal His purposes – however, it can play an important role.
3. Any prophecy will always be in part, progressive and conditional.
 - “In part” because we prophesy in part” (1 Corinthians 13:9)
 - “Progressive” – look at Abraham's life and the promises given to him. (Genesis 12 & 13)
 - “Conditional” – whether any conditions are mentioned or not. (Genesis 22:12, and 16-18)
4. A prophecy requires you to act – it is not an indication that God is doing everything and you don't need to do anything.

Hindrances – Here are a number of scriptures which outline what may stop the prophecy for your business from being fulfilled:

1. Unbelief (Hebrews 3:19)
2. Mindset (Matthew 18:21-22)
3. Wrong self-image (Exodus chapters 3 - 4)
4. Soul blockage (Jeremiah 38:19, 1 Samuel 15:24)
5. Impatience (1 Samuel 13:12)
6. Negligence, procrastination and laziness (Exodus 4:24)
7. Misapplication and misinterpretation e.g. Saul substituted sacrifice for obedience
8. Pride (Isaiah 14:13,14)
9. Disappointment and disillusionment.
10. Blame shifting, self-deception and people pleasing (1 Sam 15:20-21, 14:11-21, 20:7-12)
